## NACADA SCHOLARLY PUBLICATION ETHICAL GUIDELINES & POLICIES

All Editors and Authors of NACADA scholarly publications must sign and adhere to the policies outlined in the contract set forth by both NACADA and the joint publisher (if applicable). In addition to the publisher's contract, NACADA editors and authors must individually sign and agree to adhere to the following ethical guidelines and policies specific to NACADA:

## Authorship

Named authors should be those who contributed substantial content to the book throughout the process to include but not limited to drafting, critical revising, etc.

"Honorary authorship" is not permitted in NACADA publications. However, third parties who contributed to the content but do not qualify as named authors may be acknowledged in an acknowledgements section, subject to NACADA approval.

Coauthors should collaboratively come to agreement on author order and correct author order should be listed on all submitted work. The author who contributed the most substantial content and/or research to the work generally should be listed as the first author, followed by each subsequent author listed in descending order of contribution. Please see guidance regarding author order in APA 7<sup>th</sup> Edition, section 1.22.

Lead authors (chapter, Voices from the Field, Inquiry in Practice, etc.) are responsible for ensuring that all appropriate authors are included on the manuscript. Additionally, all listed authors are accountable for the content of the manuscript, should agree to submit the manuscript for publication, and should approve the final version before submission.

## Editor/Author Compensation

As the (co)publisher of the work, NACADA covers the full cost of the copyediting services, production, marketing, etc. of the publication in accordance with contractual partnerships between NACADA and the (co)publisher or production house. At times, editors/authors may receive gratis copies of the full publication to which they contributed which will be provided by the (co)publisher (not NACADA) or the production house. As such, editors and authors

understand that their role in the publication is voluntary and they will not be compensated for their work on the publication.

## Originality of Content & Republication of Previous Work

Authors and Editors guarantee that the work submitted is original, accurate, and does not infringe on any copyright or the proprietary rights of others.

Authors and Editors guarantee that the work submitted:

- Is not in the public domain, except for materials which permission(s) have been sought (see Permissions);
- Does not contain any libelous, defamatory, or other unlawful material; and
- Is not subject to any pre-existing contractual obligations.

In the event of such claim, action, or proceeding instituted against the author(s)/editor(s) as a result of an alleged violation of such right, the author(s)/editor(s) shall indemnify and hold harmless NACADA against all losses, costs, damages, reasonable legal fees and expenses resulting from, sustained, or incurred by reason of such claim, action, or proceeding. Republication of previously published content and self-plagiarism are considered on a case-by-case basis. General guidance for self-plagiarism may be found in section 8.3 of the APA 7<sup>th</sup> Edition manual. In the event of republication of previously published work and/or self-plagiarism, authors should disclose to editors and the NACADA managing editor how much of the content is new and how much was previously published and/or self-plagiarized.

Any representations or warranties regarding the work survive the expiration or earlier termination of the relationship. These representations and warranties are true on the date of the author's/editor's signature and on the date of publication of the work, including all intervening times. While NACADA does conduct a reference check process, NACADA is not under any obligation to independently investigate the truthfulness or accuracy of any of the author's/editor's representations and warranties.

### Citation of Sources

Authors are responsible for ensuring proper citation of sources that are included in and support the submitted content. Should allegations arise that question whether or not work was appropriately cited, these will be handled by the editor(s)/author(s), and the editor(s)/author(s) shall indemnify and hold harmless NACADA against all losses, costs, damages, reasonable legal fees and expenses resulting therefrom.

## Copyright

NACADA will hold and retain copyright to all submitted work throughout the publication development process. For single-authored pieces, should an author or editor choose to withdraw from the project (see "Discontinuation with Project" section below), the single author will retain the copyright to work previously submitted. For pieces contributed by multiple authors (coauthors), NACADA will retain copyright to all submitted content unless *all* coauthors agree to withdraw from the project. If all coauthors agree to withdraw from the project, copyright to the submitted content will be returned to the coauthor team. Reference to any copyright assignments required for either (i) NACADA to hold the copyright during the publication process; or (ii) to return (or assign) the copyright back to the author(s) or editor(s) who choose to withdraw from the project, if applicable. NACADA shall have the right to secure copyright protection in the work (if applicable), and if so, the author/editor appoints NACADA as attorney-in-fact for purposes of registering the copyright.

## Copyediting

#### Prior to submission of the work to the publisher:

NACADA outsources copyediting services with a company outside of the NACADA executive office. Author(s)/editor(s) understand that the goal of the copyeditor is to improve the content in the areas of conciseness, clarity, formatting, and adherence to APA, NACADA, and publisher guidelines. Copyeditors are not experts in the field of higher education or in academic advising. Therefore, it is up to the author(s)/editor(s) regarding what revisions suggested by the copyeditor will be accepted/rejected. Should questions arise during this process, author(s)/editor(s) will contact the managing editor who will work with the editor(s) and lead copyeditor, when appropriate, to determine correctness of the suggested revision.

#### Following submission of the work to the publisher:

In some instances, the copublisher will perform copyediting once the work has been submitted to them for publication. Author(s)/editor(s) understand that revisions are possible at the publisher's copyediting stage. However, guidelines and policies of the publisher (including formatting practices) must be followed and the publisher reserves the right to make final revision decisions at this stage and beyond.

#### Permissions

Should the authors/editors choose to use illustrations, figures, tables, etc. that have previously been published (in print, on websites, or in any other manner), it is the responsibility of the author(s) to obtain appropriate permission from the original publisher to reprint or reproduce

these items. At times, a cost may be incurred from requesting and gaining these permissions. This cost is to be paid by the authors and will not be reimbursed by NACADA. If the author is unable to gain permission from the original publisher, the author(s)/editors(s) will be required to remove the image or find one to replace it.

Modifying or adapting previously published images is acceptable. However, author(s)/editor(s) are required to obtain appropriate permission from the original copyright holder to modify or adapt the existing image.

Author(s)/editor(s) shall deliver a fully executed copy of such permission(s) to NACADA as part of their submission.

## Naming of Specific Institutions or Programs

Within NACADA scholarly publications (including books), editors and authors agree to refrain from listing specific names of institutions or programs within the content. As a non-profit association and publisher, NACADA must refrain from promoting specific entities for a variety of reasons while also working to maintain the relevancy and longevity of the content and the full publication.

This guideline does not discourage proper citation of sources that are included in and support the submitted content (see Citation of Sources), or acknowledgment of contributions made by specific third parties who contributed to the content but do not quality as named authors, subject to NACADA approval (see Authorship).

#### Errors

Author(s)/Editor(s) are responsible for ensuring the accuracy of their content. Should the author(s)/editor(s) discover a significant error in their work, they should notify the managing editor immediately. If a correction is possible (depending on the status of the publication at the time of the discovery), author(s)/editor(s) will work with the managing editor to correct the error. Errors that are unable to be corrected will be handled on a case-by-case basis.

## Conduct & Professionalism

Authors and Editors will conduct themselves in a professional and respectful manner toward NACADA and publisher staff at all times. Abusive treatment or bullying of NACADA staff by any means, including via electronic communication, will not be tolerated. NACADA reserves the right to discontinue engagement with individuals who do not adhere to these practices which could result in a discontinuation of the publication project.

## Confidentiality

Throughout the publication process, author(s) and editor(s) may have knowledge or access to the full content of the publication. Author(s) and editor(s) agree that they will not share content of the book with anyone unless otherwise approved in writing by the NACADA managing editor.

## Change in Contact Information

Copublishers with NACADA often provide copies (physical and/or e-copies) of publications to author(s)/editor(s). These copies are usually delivered to the address/e-mail address listed on the publisher's contributor contract. Should any of the author's/editor's contact information change at any time throughout the project, it is the responsibility of the author/editor to inform the NACADA managing editor so that this contract information may be updated. Should the author/editor fail to make this contact, they may not receive their allocated copies.

## Discontinuation with Project

Should any editor, author, or coauthor team choose to withdraw from the project, notice must be given in writing to the NACADA Managing Editor. All editors, authors, and coauthors will be expected to deliver their contributions as stated in the contributor contract(s) unless they formally withdraw from the project through written notice.

## Policy or Ethical Violation

Policy or ethical violations should be brought to the attention of the NACADA managing editor or managing editor's supervisor as soon as they are discovered. These instances will be handled on a case-by-case bases as deemed appropriate by the NACADA executive office.

# Note: Each Editor/Author must individually agree to, sign, and submit this agreement to the NACADA Managing Editor.

As an Editor or Author in a NACADA publication, I agree that I have read, understand, and will adhere to the NACADA ethics and policies contained within this document.
